Assessment Process

Two stages of assessment

- Stage 1 Assessment

- To be conducted by the Sub-committee Members of the Judging Panel
- Detailed assessment on the written submissions and document proof verified by the Assessor
- Site visits to selected premises may be conducted
- To shortlist best participating premises (up to 3) in each category for Stage 2 assessment by Judging Panel



Group 1 Category

1. Shopping mall
2. Residential Building / Housing Estate
3. Office Building / Commercial Building / Industrial Building
4. Hospital
5. Hotel
6. Post-Secondary Education Institution

Assessment criteria for Group 1 Categories	Weighting
1. Continual energy saving over two (2) years from 1 September 2015 to 31 August 2017	20%
2. New energy saving target with a timeline and implementation plan(s) to achieve the target	25%
3. Transparency on tracking energy saving results	10%
4. Engaging inhabitants (such as staff/ students/ occupants/ tenants) and the community to work together on energy saving activities	20%
5. Innovation and practicality on energy saving technologies and practices, including following aspects:- <ul style="list-style-type: none">● Implementing energy management opportunities identified by audits● Outperforming building energy code (BEC) for retrofit works● Signing up Energy Saving Charter 2017 and 4Ts Charter● Adopting retro-commissioning on centralized air conditioning system● Achieving Building Environmental Assessment Method (BEAM) Plus certification● Adopting renewable energy technologies	15%
6. Whether the technologies and practices in items (4) and (5) above can be modelled by other organizations in the same sector	10%

Remarks – Item (3) to (5) above also apply for assessing achievements in item (1) and implementation plan in item (2)

1. Continual energy saving over two (2) years from 1 September 2015 to 31 August 2017	30%
2. New initiatives to save energy by 4Ts approach (see below) and implementation plan, if any <ul style="list-style-type: none">● Setting energy saving targets with a timeline● Engaging inhabitants (such as staff/ students/ occupants) to work together on energy saving activities● Transparency on tracking energy saving results	20%
3. Innovation and practicality on energy saving technologies and practices, including following aspects:- <ul style="list-style-type: none">● Signing up Energy Saving Charter 2017 and 4Ts Charter● Conducting energy audit and implementing energy management opportunities identified by audit● Adopting renewable energy technologies	30%
4. Whether the technologies and practices in item (3) above can be modelled by other organizations in the same sector	20%

Remarks – Item (3) and (4) above also apply for assessing achievements in item (1) and implementation plan in item (2)
